1. EXECUTIVE COMMITTEE TO BE ELECTED

Executive Committee of SBAI to be elected for a term of 4 years (i.e) 2024-2028 from the date of election according to the Constitution of Softball Association of India:

2. MANNER OF ELECTION:

- The Elections will be held as per the provisions of the Memorandum of SBAI and the guidelines of National Sports Development Code 2011.
- The election in the event contest shall be through Secret Ballot only.
- Every member of the State Association / UT's who is in the good standing in accordance of Memorandum of Association and Byelaws of Softball Association of India, enlisted in the Electoral College to participate in the elections. State Softball Associations-02(Two); Union Territory-02 (Two), representative each shall be entitled.
- Representatives should carry necessary identity card such as Aadhar card indicating the belongingness from the concerned State/UT. Based on the same, Entry-card for SBAI - Elections will be issued.
- Duly filled-in Nomination forms in Form No: 2 to be delivered to the Returning Officer, as detailed under the following Schedule.

- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.
